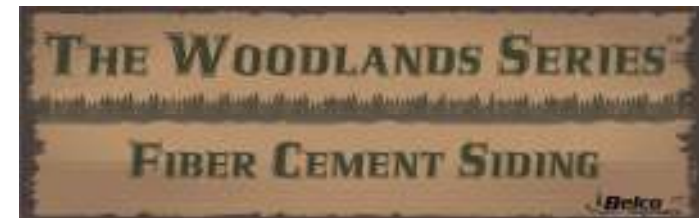

was coated is the applicable warranty

Belco Forest Products warrants to the original homeowner, for a period of fifteen (15) years from the date of application (“Warranty Period”), that when one coat of paint is factory applied over primed fiber cement siding/trim, primed composite siding/trim or primed wood siding/trim, in accordance with the standard operating procedures published by Belco Forest Products, that under normal conditions and exposure, the paint:

- ◆ WILL NOT discolor the surface below due to chalking
- ◆ WILL NOT peel or blister from properly prepared surfaces
- ◆ WILL NOT erode to expose substrate
- ◆ WILL NOT become damaged by normal rinsing of dirt

If at any time during the Warranty Period, Belco Forest Products determines that the paint has failed to meet the terms set forth in this warranty, it will, at its own discretion, and in lieu of any direct, indirect or consequential damages, furnish the homeowner with an equivalent amount of new paint to repair the affected area(s). This non-prorated warranty is for paint *only*, and does not include labor or cost of labor for application of the paint or installation of the siding/trim. The cost of replacement substrate or other expenses such as accessories (sheathing, fasteners, caulking, etc) which may arise in connection with this warranty, are not covered by this warranty. As an alternative to paying replacement costs, Belco Forest Products reserves the right, at its option, to credit or refund the purchase price of the defective paint. In no event shall Belco Forest Products’ obligations under this warranty exceed the purchase price of the original finished product.

Failure to read and follow the installation instructions published by the substrate manufacturer and the terms, conditions, requirements, limitations and exclusions stated in said document, will void the warranty. Any siding/trim found to be unsatisfactory prior to installation, must not be installed and should be returned to the dealer where it was purchased for replacement siding/trim. Belco Forest Products will not be responsible in any way if defective or unacceptable siding/trim is installed.

**WARRANTY LIMITATIONS & EXCLUSIONS**

This warranty is non-transferable and does not cover loss or damage of any kind resulting from any of the following:

- ◆ **Improper Storage & Installation**, including failure to follow substrate manufacturer’s storage & handling or installation recommendations, or installation of a poor quality substrate
- ◆ **Improper Construction & Maintenance**, including but not limited to, accidental damage, damage from falling objects, structural defects, removing mildew, caulking of siding/trim, touching up damaged areas, other appropriate maintenance or abrasions from rubbing, scratching, dents, dings, or other misuses of the factory-finished product after application

- ◆ **Excessive Warping, Cupping, Splitting, Checking & Shrinkage** of siding/trim, as defined by industry standards
- ◆ **Mildew & Color Appearance**, which are not a manufacturing defects and therefore are not covered by this warranty. Depending on the color, additional coats may be required to provide the desired result
- ◆ **Substrate Failure**, including cracking or primer failure
- ◆ **Cracking, Peeling & Blistering** as a result of inadequate ventilation or improper construction techniques
- ◆ **Cracking, Peeling, Blistering & Efflorescence** caused by the primer or inadequate primer application as is supplied/applied by siding/trim manufacturer
- ◆ **Excessive Moisture** in the siding/trim or excessive expansion, contraction or other movement of the siding/trim
- ◆ **Exposure** to harmful chemicals (including harmful cleaning compounds), fumes, vapors, salt spray, air pollutants, vandalism or other abuse/misuse that may result in surface deterioration
- ◆ **Extreme Weather Conditions**, such as hail, lightning, tornado, fire, windstorm or other act of God. Color change or fading due to sunlight exposure or extreme weather conditions is not covered by this warranty. Belco Forest Products will not be responsible for any replacement coating that varies in color or gloss as compared to the original due to normal weathering of product. Depending on exposure or wear, evaluate recoating needs every eight (8) to ten (10) years
- ◆ **Any other damage that was not caused by a defect in the coating or factory application**

Belco Forest Products reserves the right to discontinue or modify any of its paints (including color) at any time, without notice to the consumer, and will not be liable as a result of such discontinuance or modification. If this occurs and Belco Forest Products replaces any material under warranty, it may substitute paints of comparable quality and/or price.

THE DURATION OF ANY IMPLIED WARRANTY SUCH AS WARRANTIES OF MERCHANTABILITY AND FITNESS ARE LIMITED TO THE WARRANTY PERIOD AS DESCRIBED ABOVE OR BY APPLICABLE STATE LAW. THIS LIMITED WARRANTY IS IN LIEU OF ALL OTHER EXPRESS WARRANTIES. BELCO FOREST PRODUCTS MAKES NO OTHER EXPRESS WARRANTIES, AND DOES NOT AUTHORIZE ANY OTHER PERSON OR AGENT TO MAKE ANY OTHER EXPRESS WARRANTIES. BELCO FOREST PRODUCTS’ OBLGATIONS, RESPONSIBILITIES AND/OR LIABILITY IS STRICTLY LIMITED TO REPLACING OR REFUNDING THE DEFECTIVE PAINT AND IN NO EVENT SHALL BELCO FOREST PRODUCTS BE LIABLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES THAT RESULT FROM BREACH OF WARRANTY. SOME STATES DO NOT ALLOW EXCLUSIONS OR LIMITATIONS OF INCIDENTAL OR CONSEQUENTIAL DAMAGES SO THE ABOVE LIMITATIONS MAY NOT APPLY TO YOU. THIS LIMITED WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS AND YOU MAY HAVE OTHER RIGHTS THAT VARY FROM STATE TO STATE.

NOTICE OF CLAIMS

All claims must be submitted in writing to the installer, who must be afforded a reasonable opportunity to take corrective actions or to notify responsible parties. If a claim is not resolved within 30 days after notice to the installer, written notice\* must be given within the Warranty Period to Belco Forest Products, Attention: Woodlands Series Product Manager, 1890 E Johns Prairie Rd, Shelton, WA 98584. Belco Forest Products must then be given a reasonable opportunity to investigate the claim before corrective action is taken.

*\*If product registration has been completed, only written notice is required. However, if your purchase is not registered with Belco Forest Products, written notice and a copy of the receipt or other proof of purchase is required before Belco Forest Products will take any action.*
